This role provides direct oversight, mentorship, and operational guidance to Patrol Captains, ensuring alignment with Surf Life Saving Northern Region's standards and values.

As a key conduit between frontline lifeguards and the Lifesaving Support Officer, the Supervisor fosters clear communication, escalates operational needs, and promotes continuous improvement across the region.

KEY RESPONSIBILITIES

1. Patrol Oversight & Support

- Supervise daily lifequarding operations across Ōmaha, Tāwharanui, and Pākiri, ensuring safe, professional, and community-focused patrol delivery.
- Provide on-beach leadership and operational support to Patrol Captains and lifeguards, especially during high-risk or complex conditions.
- Monitor unpatrolled beaches within the Omaha Bay area, assessing risk and responding to emerging hazards.
- Educate and advise members of the public on water safety, surf conditions, and responsible beach use.

2. Leadership, Communication & Team Development

- Conduct regular 1:1 check-ins with Patrol Captains to provide coaching, gather feedback, and support leadership development.
- Foster open, transparent communication between patrol teams and the Lifesaving Support Officer (LSO), ensuring timely escalation of issues and shared accountability.
- Support Patrol Captains in maintaining high standards of patrol delivery, team culture, and operational readiness.
- Coordinate and facilitate lifeguard training and upskilling across Omaha Bay patrol sites, enhancing fitness, technical proficiency, and leadership capability.

3. Equipment & Facilities Management

- Ensure all lifesaving equipment, vehicles, IRBs, and facilities are maintained to a high standard in accordance with Standard Operating Procedures.
- Conduct regular inspections, log faults, and promptly notify the LSO or PLS Management of any resourcing needs or operational risks.
- Maintain familiarity with Maritime Rules and Regulations, including 5-knot laws, and ensure compliance during patrol operations.

4. Risk Management & Compliance

- Apply risk-management principles across all supervised beaches, identifying, assessing, and mitigating hazards in line with SLSNR protocols.
- Complete and submit all required paperwork, incident reports, statistics, and administrative tasks accurately and on time via the Surf Patrol App (SPA).

- Ensure strict adherence to SLSNR and SLSNZ policies, procedures, and operational standards at all times.
- Assist the LSO in monitoring beach performance and patrol preparedness across sites.

5. Stakeholder Engagement & External Relations

- Represent the Paid Lifeguard Service, SLSNR, and SLSNZ positively in all interactions with the public, local clubs, and emergency response agencies.
- Maintain collaborative relationships with SurfCom operators, club leadership, SAR teams, and other stakeholders to ensure seamless communication and joint response capability.
- Support joint exercises and interagency coordination as required.

6. Continuous Improvement

- Contribute to ongoing improvement efforts by identifying gaps in patrol operations, training needs, or resource constraints.
- Capture frontline insights and share practical feedback with the LSO to refine patrol practices and enhance regional effectiveness.
- Encourage a culture of open discussion and innovation, where lifeguards feel empowered to suggest improvements and take ownership of their development.
