- Provide unlisted and unit trust transaction advice to the CIP network, advisers and assistants.
- Collaborate with IT on development, improvements and testing of the Pie Processing Tool & International Fund Tool.
- Onboarding of new Unit Trust/Funds.
- Liaise with external registries, auditors, and other teams as required.
- Facilitate PIR rate changes.
- Mentor Custodial team members, assisting with cross training and providing back-up to other roles within the CSL team
- Ensure adherence to custodial policy and process documentation as appropriate, ensure procedures remain current.
- Contribute to the Me He Te manual (for standard operating procedures) as requested.
