# **Role Purpose**

The supply chain and procurement function is a strategic business partner to 10 wholly owned and 6 JV hospitals that form the Southern Cross Healthcare group. The purpose of the role is to define and execute category strategies, run sourcing activity manage shortages and ensure products and services meet legislative and SC requirements.

As a member of the Procurement team, you will be responsible for:

- Develop category plans in alignment with the business in relation to allocated portfolio
- Provide product sourcing services to the Southern Cross Healthcare group;
- Coordinating product evaluations and produce recommendations for all aspects associated with medical device introductions, substitutions, recalls, off-label use / noncompliance to IFU indications, & NZ Medsafe legislation;
- Effective communications and influencing the hospital group in the use of appropriate medical consumable products and single use devices, aligned with the SC strategic direction and complicit clinical policies and guidelines;
- Identify and action improvements in procurement and supply chain activities.

### Leadership

- Source, assess and validate medical devices (Capital + Consumables) and act as a conduit between suppliers and our hospital network.
- Identify and implement opportunities to improve procurement or supply chain processes.

- Develop and document Category plans across the allocated portfolio
- Identify and deliver on initiatives that result in cost savings
- Maintain and develop supplier relationships to maximize business opportunities and product support.
- Identify cost saving opportunities within the existing supplier base and negotiate changes with relevant supplier/organization.
- Manage performance of contracted suppliers to maximize benefits for the hospital network.
- Identify new procurement opportunities and negotiate terms that will improve the hospital network business performance.

#### **Customer Focus**

- Facilitate trials and evaluations across SCH group to ensure best products are available on the NZ market.
- Maintain and develop internal relationships to maximize level of influence within the hospital group.
- From time to time, manage the procurement helpdesk and provide support on enquiries related to consumable purchase/selection.
- Lead robust product evaluation initiatives for all new products (as appropriate) and involve end-users in the decision-making process.
- Support clinical staff by coaching them through the hurdles of new product introductions so they can maintain their clinical and patient care focus.
- Manage product alerts and the recall quarantine process in order to minimise any risks to patients and staff.
- Responsible for managing new product requests, due diligence for medical consumables, medical devices, therapeutic products and hazardous goods.
- Co-ordinate and manage all requirements for product and supplier code changes within SCH national catalogue and identify suitable substitutions.
