Role Purpose

To provide, as part of the wider OR team, a high standard of sterilising service. The TL will report directly to the -Theatre Services Manager. This specifically involves reprocessing of contaminated sets of surgical instruments, accessories and other related equipment used within our operating theatres, providing decontamination, inspection, testing, assembly, packing and sterilisation of reusable medical devices as per manufactures instruction for use and in line with national or local documents.

Team leaders work alongside the SSD team members to foster good relationships to ensure efficient service delivery Team leaders are responsible for providing ongoing education, performance reviews and assessment of practice and appropriate documentation for SSD technicians. The role will include participating in the standard tasks of the Sterile Services Team as well as providing the team leadership as described.
