Purpose

This role involves assisting the Shift Manager with managing, controlling, and ensuring sufficient packaging supplies are provided to packing teams to enable continuous, efficient packing operations.

Responsibilities

- Provide packaging supplies to packing teams to ensure efficient packing operations.
- Liaise with Inwards Goods team for timely delivery of packaging needed.
- Check packaging for defects when unpacking.
- Ensure traceability of waste packaging is recorded.
- Escalate any issues regarding defects to the Shift Manager.
- Ensure packaging traceability is maintained using Rockit systems.
- Undertake regular packaging stocktakes to ensure correct packaging is on-site.
- Liaise with Techs to ensure packaging changeovers are completed correctly and efficiently.
- Co-ordinate with lane & mezzanine chargehands.
- Comply with company Health and Safety procedures and contribute to a positive safety culture.
- Assist training of general floor staff in their roles.
- Liaising with quality staff.
- Enforce food safety requirements including spot checks on staff of general hygiene, absence of Jewellery etc.
- Undertake other duties in the packhouse as required.

Supervision

- Supervise, train and mentor team members to be great in their role.
- Train staff against SOP's and sign off when competent at each level.
- Support the growth and development of the Packaging Co-ordinator support person(s).

Essential Requirements

- Have competent computer skills, to use appropriate inventory software such as Microsoft Office, especially Excel and ABC Software.
- A positive attitude and a can-do attitude is particularly important. Pro-active input to teamwork and process improvement is critical in this rapidly expanding company.
